Per Centers of Disease Control and Prevention data, more than 110,000 Americans died of fatal drug overdose in 2022. At least 4,000 of those deaths occurred in Tennessee and well over a quarter of those took place in East Tennessee. We believe those numbers are underestimated. Review of medical records of drug overdose victims reveal a number of previous emergency room, urgent care, and primary care visits in most of those cases. Almost all of those instances presented different points of either missed opportunities or failed interventions for their drug addiction. In this presentation we will discuss the medical examiner's role in gathering, interpreting, and disseminating data used by the public health officials, health care community including addiction specialists, and law enforcement. Our data has also been utilized for surveilling successes and/or failures of different preventative and treatment modalities used in the so-called "war-on-drugs." Finally, an emphasis will be made on novel synthetic drugs of abuse, their development, supplies, and distribution chains in order to predict the future trends and their general impact on our communities and the society at large.

Anatomy of a Relapse

Kristen Robinson, is a LADAC, Level II and NCAC, Level II. She works at Village Behavioral Health in Louisville, TN and created the THRIVE Program to address all types of addictions. Kristen got her undergraduate degree from ETSU and has worked in different levels of treatment. She was a nominee for the Knoxville Sphere Award in 2009 by the City of Knoxville. Kristen was nominated for ETAADAC Catherine S. Scarlett Award in 2015, 2016, and received it in 2019.

Summary of Presentation: The purpose of this workshop is to help professionals expose unhealthy conditions and sequences that are located within the anatomy of a relapse. Participants will examine the complex patterns and disruptive cycles that often occur during periods of abstinence that exacerbate the probability of relapse. Case studies about persons with substance use and/or process disorders will be presented that include effective techniques to interrupt or reverse the relapse process through the use of analyzing the individuals own

experiences and specific behaviors. This interactive workshop will allow professionals and their patients how to learn and develop skills from their past experiences so that they are no longer a source of shame, but provide remarkable fuel their recovery.

Description of the Presentation: As professionals you work diligently to help your patients transform their lives. Recovery is impacted by each patients specific addictive behaviors that increase the probability of relapse. This workshop focuses on providing an in-depth analysis of a relapse to assist patients in recovery. Case studies about persons with addictions will be dissected to examine the complex patterns cycles that fuel relapse. It will include information and techniques to fuel the recovery by identifying unhealthy parts in the relapse that create the initial lapse. Understanding the anatomy of a relapse to interrupt (or reverse) the process can empower a patients ability to maintain recovery.

Learning Objectives:

Objective 1: Complex patterns and disruptive cycles that are hidden within the relapse process will be identified and analyzed as a way to reinforce recovery.

Objective 2: Case Studies from individuals with substance use and/ or process disorders will be explored as an effective tool to uncover the cause of the initial lapse. The case studies will also provide clarity to the process that facilitated the relapse.

Objective 3: Participants will be provided vital information that allows their patients to utilize their specific relapse process as a resource that fuels their recovery.

She has been awarded the Professional Of The Year through ETAADAC 2013 and the Lifetime Achievement through ETAADAC in 2016. She is past president of ETAADAC x2 and Past President of TAADAC. Presentation Title: Creating an Intentional Culture in the Therapeutic Community

Bio: Karen Moran, LADAC II, NCAC II, QCS is a clinician and consultant in Nashville, Tennessee, and has actively promoted wellness, recovery, and professionalism in the treatment community for over thirty years. Recognized for her specialized skills and expertise with substance use disorders, Karen also has also provided clinical supervision to over 100 clinicians, spanning over 25 agencies, as well as cofacilitates 8 Domain training with Pleiades Clinical Consulting.

This Session will include small and large group work, centering around the elements of an "intentional" culture; what it means to have one, and what the value is to the client community as well as the therapeutic team. Participants will share elements of their current clinical culture, to include culture around nicotine and caffeine, privacy, self-care, clinical philosophy, and clinical team collaboration, to name but a few. Each participant will then have an opportunity to design their ideal intentional culture, based on that clinician's own philosophy and best practices, as well as identify immediate action steps to implement those practices within her/his/their own program.

Learning Objectives:

- 1) Identify core values and beliefs regarding best practices for client care.
- 2) Demonstrate understanding of how creating an intentional clinical culture integrates core values and

enhances the clinical experience for clients and clinical team

3) Explore old habits and cultures that do not match core values, identifying ways to begin to place more

intention around those structures.

Brief Bio 2023 Dr Daniel Sumrok

Daniel Sumrok MD is a Fellow of the American Academy of Family Practice and a Distinguished Fellow of the American Society of Addiction Medicine. He is the current president of the Tennessee Society of Addiction Medicine and will finish a three year term in April of 2023.

He is board certified in family medicine, addictions, and preventive medicine and served on the UT Health Science Center College of Medicine faculty from 1991 to 2022. Dr Sumrok got his bachelor's degree from West Virginia University and MD from Marshall University and did master's work in community medicine at Marshall where he also became a CDC certified epidemiologist.

Dr Sumrok has been a leader in rural healthcare in Tennessee for more than 3 decades and delivered babies in McKenzie, Huntingdon, Jackson, and Memphis, while sponsoring a women's healthcare fellowship in McKenzie that was highly regarded by UT and its trainees

In 2005 he became one of North America's first group of 106 doctors board certified in Addiction Medicine and was able to help found the specialty and gain its recognition by the American Board of Medical Specialties.

In 2015 he started the Center For Addiction Science at the University of Tennessee Health Science Center in Memphis and in 2017 the program was recognized by the American Board of Addiction Medicine as the United States first center of excellence for training physicians in addictions care.

Dr Sumrok has worked in the Obama, Trump, and Biden White Houses and is particularly known for his trauma research, education, treatment and community outreach in addictions care.

He has served in the military from the jungles of the equator to the Acrtic and from Apache to Appalchia caring for marginalized people.

Declining to retire, Dr. Sumrok was recruited as the medical director of Steppingstones to Recovery and Cornerstone of Recovery by Webster Bailey in March of 2022. Dr Sumrok moved with his wife ,Marquita and teenage daughters ,Abigail and Lydia, to Maryville in June of 2022.

In September, Dr Sumrok and his colleagues at Bradford Health began an outpatient program at Cornerstone that is currently serving more than 200 clients with SUD from across East Tennessee using the latest approaches to trauma informed MAT, group, and individual counseling.

The licensed outpatient center serves people across the demographics from Tenncare to blue collar workers and professionals and recently passed its first state inspection with high marks.

Dr Sumrok is a nationally known speaker in topics of addictions care.
